**FINAL ORDER**


NOW, on this 17<sup>th</sup> day of December 2009, the above-captioned matter was submitted to the Public Employee Relations Board (PERB) for consideration of Petitioner's request for the PERB to review the *Order on Respondent's Motion for Dismissal* issued by the Presiding Officer on November 19, 2009.

The PERB finds and concludes that the record contains substantial evidence supporting the Presiding Officer's findings of fact and is not otherwise unreasonable, arbitrary or capricious. Further, the PERB discerns no errors in the application of law to the findings of fact. Lastly, the PERB finds no basis for the Petitioner's challenge of the Presiding Officer's order.

The PERB herewith denies the Petitioner's request for review.

Therefore, the *Order on Respondent's Motion for Dismissal* shall become the Final Order of the PERB pursuant to K.S.A. 77-530(b)(2) without further review or modification.
