INITIAL ORDER

COMES NOW on for consideration by presiding officer, Susan L. Hazlett, the Respondents' pleadings and requests for dismissal therein. The Petition in this matter was filed pro se on December 10, 1996. The Respondent Teamsters #696's Answer was filed by and through counsel, Thomas H. Marshall, on December 24, 1996. The Respondent Shawnee County Commissioners' Answer was filed by and through counsel, Sandra Jacquot on January 6, 1997. All parties filed prehearing questionnaires at the request of the presiding officer. A prehearing conference was scheduled for February 19, 1997, but the Petitioner notified the presiding officer that she would be unable to attend. The presiding officer, after being duly advised of the premises, finds:

1. That Petitioner states as her theory of claim:

I am a member of Teamsters Local 696 and employed in the Shawnee County Motor Vehicle Department and according to K.S.A. 75-4324 I am entitled to union representation with respect to grievances and conditions of employment. Said Respondents have refused to follow the declared grievance process as spelled out in the Agreement breaching the duty of fair representation. Respondents have engaged in a wrongful pattern and practice of conducting grievance hearings on open public record disclosing private personnel

information to the public. This is a Shawnee County Commission controlled Union because Respondent County can refuse to recognize the Teamsters Local 696 as the employees representative and can choose another Union to represent the County employees. Therefore Respondent Union does not or refuses to file grievances. This is a fraudulent situation because the Teamsters Local 696 is taking my dues knowing that the Board of County Commissioners can end the tenure of the Teamsters Union. (Pet. Prehearing Questionnaire);

2. That the complaint in this matter fails to allege one or more prohibited

practices, or facts in support thereof, within the meaning of K.S.A. 75-4333, and Petitioner

has failed to state a claim upon which relief can be granted under the Public Employer-

Employee Relations Act (PEERA);

3. That the Public Employee Relations Board (PERB) has no authority to enforce

contracts or to sanction for contract violations;

4. That the PERB has no obligation or authority to appoint or provide legal

representation for a party, as requested by Petitioner;

- 5. That this case should be and is hereby dismissed for the aforestated reasons; and
- 6. That the Respondent Teamsters #696 request for attorneys' fees and expenses is denied.
