**SUBJECT** Withdrawal of Representation - Shawnee County  
(Appraiser's Unit)

The attached "Notice of Intent to Withdraw as Representative" has been posted by **Shawnee County** through the period which ended on **March 15, 1994**, notifying the members of the bargaining unit there that the **Teamsters Local Union #696** had filed a notice with the Public Employee Relations Board of its intent to disclaim any interest in representing the bargaining unit **effective May 1, 1994**.

No employees provided information showing why the **Teamsters Local Union #696** should not be allowed to withdraw as representative of certain employees of the **Shawnee County** bargaining unit, nor has any organization or group of employees petitioned the Public Employee Relations Board to represent the bargaining unit.

Accordingly, effective **May 1, 1994**, the **Teamsters Local Union #696** designation as the certified employee representative for the bargaining unit is withdrawn, and its obligations to represent the members of the bargaining unit have ceased. **Shawnee County** is relieved of its obligations to meet and confer with the **Teamsters Local Union #696** pursuant to K.S.A. 75-4327(b).

Any employee organization or group of employees wishing certification as the recognized employee organization of Shawnee County, Kansas Appraiser's Unit may file with the Kansas Public Employee Relations Board a petition for unit certification election in accordance with K.S.A. 75-4327(d).
