Pursuant to the mutual agreement of the parties, and the Board finding no statutory violation in the proposed action to amend 75-UCA-5-1990, hereby orders that the appropriate unit for Professional Employees within SRS and its institutions be established as follows:

**INCLUDE:** Human Services Consultant  
Human Services Counselor  
Human Services Specialist  
Social Worker  
Social Worker Specialist

**EXCLUDE:** All managerial, confidential, supervisory and temporary employees in classes otherwise included and all other classes not specifically included.
