ORDER TO AMEND

Now, on the 31st day of January 2022 the above captioned matter came on for consideration before the Public Employees Relations Board (Board).

The Petition for Unit Clarification or Amendment (Petition) was submitted by both parties, pursuant to K.A.R. 84-2-7. According to the Petition of the parties, and after consideration by the Board pursuant to K.S.A. 75-4327(c), the appropriate unit for the Kansas State University as previously ordered in 75-UCA-10-2020 shall be amended and comprised of the following classifications, in accordance with K.S.A. 75-4327(e) and K.A.R. 84-2-6:

Include: Agricultural Technician I, Agricultural Technician II, Agricultural Technician I Research, Agricultural Technician II Research, Animal Technician I, Animal Technician II, Carpenter, Construction Worker, Cook, Custodial Specialist, Electrician, Electronics Technician, Energy and Utilities Technician, Extension Nutritional Assistant, Food Service Worker, HVAC Technician, Laboratory Animal Technician I, Laboratory Animal Technician II, Laboratory Animal Technician III, Laboratory Technician, Landscape Technician I, Landscape Technician II, Lock System Specialist, Machinist, Maintenance and Repair Technician I, Maintenance and Repair Technician II, Painter I, Painter II, Parking Assistant I, Pest Control Worker, Plumber, Power Plant Operator, Printing Service Coordinator, Printing Specialist, Recycling Technician, Teaching

Laboratory Specialist, Utility Locator, Vehicle/Equipment Mechanic, Veterinary Nurse I, Veterinary Nurse II, Veterinary Nurse III, Welder

Exclude: Office, clerical employees, all professional employees, elected and management employees, officials, uniformed police employees, security guards, and supervisory and confidential employees as defined in the Act under K.S.A. 75-4322, and all temporary, student and emergency employees.



RIGHT TO REQUEST HEARING


