## UNIT AMENDMENT ORDER

ON the 4th day of August, 1993, the above-captioned petition for unit clarification and amendment came on for review. Pursuant to the mutual agreement of the parties that the following classifications should be excluded from the Clerical Unit for Unified School District 500, Kansas City, Kansas, established in 75-UDC-8-1993, and there being no statutory violation found in the proposed action, it is determined that the appropriate unit shall be comprised of the following classifications:

**INCLUDE:** All secretaries employed by the Board of Education of Unified School District No. 500, Wyandotte County, Kansas, and placed on the secretaries' salary schedule.

**EXCLUDE:** Secretary for the Superintendent of Schools; Secretary for the Assistant Superintendent for Personnel; Secretary for the Assistant Superintendent for Business Affairs; Secretary to the Assistant Superintendent for Instruction Leadership; Secretary to the Assistant Superintendent for Pupil and Parent Services; Secretary for the Director of Special Education; and Secretary serving in the capacity of Clerk of the Board of Education.
