**INCLUDE:** All employees bearing the rank of Firefighter, Fire Lieutenant and equivalent positions, Fire Captain and equivalent positions, Lieutenant Airport Safety Officer and equivalent positions, Captain Airport Safety Officer and equivalent position.

**EXCLUDE:** All other employees not specifically listed above.
