ORDER TO AMEND

NOW, on the 21st day of September, 1995, the above-captioned matter came on for consideration by the presiding officer, George M. Wolf. This amendment is a result of the Kansas Association of Public Employees (KAPE) petition in case numbers 75-UC-1-1995 and 75-UCA-3-1995.

Pursuant to the mutual agreement of the parties, the classification of Liquor Control Investigator II should be removed from the statewide unit of Non-Professional Inspection and Regulatory Employees (case number 75-UCA-3-1989) and placed in the Statewide Unit for the Kansas Bureau of Investigation (KBI). There being no statutory violation found in the proposed action, it is hereby ordered that the appropriate unit in the above-captioned matter shall be comprised of the following classifications:

classifications.)


