ORDER TO AMEND

Now, on the 30th day of November 2023 the above captioned matter came on for consideration before the Public Employees Relations Board.

The Petition for Unit Clarification or Amendment was submitted by the International Association of Firefighters Local #135, pursuant to K.A.R. 84-2-7. The Respondent did not object to the Petition. After consideration by the Board pursuant to K.S.A. 75-4327(c), the appropriate unit shall be amended and comprised of the following classifications in accordance with K.S.A. 75-4327€ and K.A.R. 84-2-6:

Include: All employees bearing the rank of Firefighter, Fire Lieutenant and equivalent positions, Fire Captain and equivalent positions, Lieutenant Airport Safety Officer and equivalent positions, Captain Airport Safety Officer and equivalent positions, Medical Officer and Emergency Medical Responder.

Exclude: All other employees not specifically listed.

Pursuant to the mutual agreement of the parties, and by the authority vested in the Board by the Public Employer Employee Relations Act (K.S.A. 75-4321, et seq.) including the authority granted pursuant to K.S.A. 75-4327(c) and K.S.A. 75-4323(e)(3). It is hereby ordered to adopt the name change of the unit and job classifications as

noted cited. Chairwomen Franklin did not participate in the deliberations or vote on this question.

RIGHT TO REQUEST HEARING


