AMENDED UNIT DETERMINATION ORDER

ON the 21st day of August, 1996, the above captioned matter came on for the Kansas Public Employee Relations Board pursuant to Respondents' petition for review of the hearing officer's initial order. Prior to the meeting of the Board, attorneys for the parties met with hearing officer Monty R. Bertelli and were able to reach a mutually agreeable settlement to the dispute resulting in the appeal.

The parties have stipulated that in return for the Respondents withdrawing their petition for review, Petitioner would agree to the exclusion of the Safety Supervisors (Training Captains) from the bargaining unit.

IT IS THEREFORE ORDERED, that the appropriate bargaining unit shall be composed as follows:

INCLUDE: Safety Officer II
Safety Officer I
Full and part-time employees in the
included positions.


EXCLUDE: Director of Airports
Director of Airport Operations
Chief of Airport Safety
Assistant Chief of Airport Safety

Safety Supervisors (Shift Captains)
Safety Supervisors (Training Captains)
Assistant Safety Supervisors (Shift
Lieutenants)

IT IS FURTHER ORDERED that a pre-election conference shall be held on September 24, 1996 by telephone conference call. Attorneys shall contact Sharon Tunstall at the PERB office and give a telephone number where they can be reached at that time. The parties shall also agree, if possible, to a date for the election, and whether the election shall be held on-site or by mail-back ballot. Finally, Attorney for Respondents shall send to the PERB office as soon as possible a list of employees employed by the Respondent Airport Authority on the date the petition for unit determination and certification was filed for the purpose of verifying the Petitioner's showing of interest.
