**UNIT DETERMINATION ORDER**


NOW, on the 22<sup>nd</sup> day of August, 2005, the above-captioned matter came on for consideration before the Executive Director, Douglas A. Hager.



NOW THEREFORE, having heard the statements of counsel and examined the pleadings heretofore submitted by the parties, the Board finds that:


1. A bargaining unit consisting of patrol officers and master patrol officers shall be and the same is hereby created and recognized within the Police Department of the City of Derby, Kansas.


2. The Public Employee Relations Board shall conduct a representational election within such bargaining unit in accordance with K.S.A 75-4327(d).
