Dear Mr. Brindle:

The subject case was reviewed and the unit determined by the Public Employee Relations Board at its meeting April 17, 1975, for certain employees of the Kansas Turnpike Authority and is as follows:

INCLUDE: Toll Collectors I, II, and III

(All employees holding permanent, provisional, probationary, part-time, intermittent and in-lieu-of appointments, will be included.)

EXCLUDE: All other employees, as appropriate, pursuant to K.S.A. 75-4327(c)

(All employees appointed on a temporary, seasonal, student, emergency, and exceptional basis will be excluded.)

We request that an alphabetical listing of all employees of the appropriate unit - including their addresses and social security numbers - be forwarded to this office at your earliest convenience. This is in accordance with PERB rule 84-2-5(b) which states....."All public employers shall be required to furnish the Board with an alphabetical listing of all employees within the appropriate unit as expeditiously as possible, not to exceed 30 days after the filing of a petition for a certification election following unit determination, unless otherwise directed by the Board or its agent."
