# SUMMARY PROCEEDING

(Pursuant to K.S.A. 72-537(a))

NOW, on this 27th day of April, 1990, upon review of the agency file in 75-UDC-5-1990, there appears to be an ambiguity as agencies covered by the Certification to the state of Representation and Order to Meet and Confer dated February 23, 1990. While the pleadings are directed to the Department of Social and Rehabilitation Services (SRS); the list of voters eligible to vote in the February 5-15, 1990, mail-back election included employees classified as Social Workers II and employed by at least one other agency. The records of the Department of Administration further disclose at least three agencies other than SRS (Commission on Veteran's Affairs, Department of Health and Environment and Department of Corrections) with employees in the classification of Social Worker II.

It is important that this ambiguity be resolved so the parties may proceed with meet and confer and the requisite state agencies

are included in those negotiations. From review of the file and comments from KAPE and SRS representatives, the unit should be limited to employees of SRS.

IT IS THEREFORE ORDERED that the appropriate unit in 75-UDC-5-1988 is as follows:

- INCLUDE: Income Maintenance Worker I Income Maintenance Worker II Social Worker I Social Worker II Social Worker III at SRS State Hospitals and Youth Centers. Employed by the Department of Social and Rehabilitation Services.
- **EXCLUDE:** All managerial, confidential, supervisory employees in classes otherwise included and all other employees not specifically included employed by the Department of Social and Rehabilitation Services.

### REQUEST FOR HEARING

The parties are advised they may request a hearing on this Order pursuant to K.S.A. 77-537(b) by filing a request with the Public Employee Relations Board, 1430 SW Topeka Blvd., Topeka, Kansas 66612-1853, within fifteen (15) days of service of this Order, setting forth the issues to be decided at the hearing. If a hearing is not requested, the order shall become effective upon the expiration of the time for requesting a hearing.
