We are writing to confirm the discussions between R. A. Caraway, AFSCME International Representative, and yourself on the unfair (election) practice [Request for (Election) Review/Objection] by the City of Manhattan pending before the PERB.

Accordingly, please consider said Request withdrawn by AFSCME and thus remove the matter from today's agenda.

For your infromation, Ed Horne, Manhattan city attorney, has been advised of this decision and the rationale therefor: 1) an anticipation that AFSCME and the City will have another opportunity to tackle the employees' best interest—either through a modified or different appropriate unit or otherwise through a future election; and 2) the attitude of some of the employees as a result of management innuendoes or misunderstood gestures and remarks.
